ID Proof

Address Proof

- 1 UIDAI/Aadhaar - Mandatory - For all directors and authorised signatories **AND**
- 2 Overseas address proof - *In case any director/authorised signatory is an NRI*
- 3 Bank statement of Private Limited Company with stamp & signature (first & last page should reflect **current** month's entries)

- 2 Overseas address proof - *In case any partner/authorised signatory is an NRI*

ACCOUNT TYPE - TRUST**ID Proof**

Address Proof

- 1 UIDAI/Aadhaar - Mandatory - For All trustees **AND**
- 2 Overseas address Proof - *In case any trustee is an NRI*
- 3 Current address proof of Trust (*Not more than 2 months old*) (E.g. Electricity Bill, Bank statement, telephone bill)

Bank Proof
